
IV. Terms and Termination of the MOU

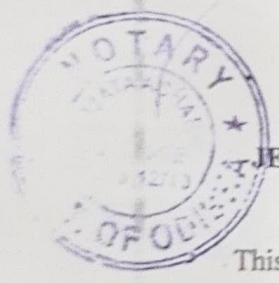
