INTERNAL POLICY OF JEYPORE COLLEGE OF PHARMACY (REGARDING RELAXATION OF FEES OF STUDENTS)

Jeypore college of Pharmacy, Rondapalli, Jeypore, Dist: Koraput, Pin:764002 has been functioning with in Bachelor in Pharmacy course since 2001, diploma in Pharmacy since 2002 and as well as Master in Pharmacy since 2006, to eradicate the needs and use of pharmacy education in the thickly habituated of tribal people of undivided Koraput tribal district. The desirous students of arrounding and surrounding of undivided Koraput and adjourning other states are being taken admissions and some of have completed their pharmacy education in different courses by depositing the fees as fixed by the state government of Odisha from time to time. It has also been experienced that, some students having poor economic conditions were taken admissions and have requested for concession of fees. The college is granting the concession some of the reception basing on the economic condition of the parents of the students. Though the SC/ST / OBC students are getting Post-Metric Scholarship from the state government but the same is not equal to the course fees with other ancillary essential need like uniform, Transportation, and hostel fees for which the students of above categories are also approaching for relaxation of fees. This has also been granted taking in to the measurable economic condition, however there is no statutory principle to this regard Consideration.

It is therefore felt necessary to formulate a principle to relax the fees of the students on the following manner in future to maintain regular & uniformed standard.

- 1. Rs.5000/- to Rs.10,000/-per annum will be relaxed to the students whose parents economic conditions is not so well.
- 2. Rs.10,000/- to Rs.20,000/- to the students whose parents are serving in the institution.
- 3. Rs.5000/- to Rs.20,000/- to the students whose parents assisting outside for betterment of the institution.
- Rs.5000/- to Rs.20,000/- to the students whose parents are suffering as physically Handicapped and Long Treatment medical chronic diseases and have no permanent sources income

This Internal Policy shall came into force from the next academic year 2017-18 onwards. Peur
